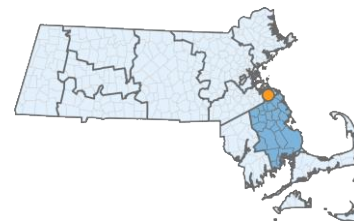


Hingham (Plymouth)

Hingham is a town in Plymouth County with 5,632 residents aged 65 and older. Compared to state average rates, older residents in Hingham report lower rates of tooth loss, chronic obstructive pulmonary disease (COPD), diabetes, heart attack, substance and tobacco use disorders, PTSD, and schizophrenia. However, they have higher rates of hip fracture, Alzheimer's disease or related dementias, anemia, atrial fibrillation, breast cancer, cataract, congestive heart failure (CHF), fibromyalgia/chronic pain/fatigue, glaucoma, ischemic heart disease, migraine, osteoarthritis/rheumatoid arthritis, osteoporosis, peripheral vascular disease, pressure ulcer, prostate cancer, stroke, and high cholesterol. Older Hingham residents are more likely to take the health promotion steps of engaging in physical activity and receiving annual physical exams. Community resources to support healthy aging include a COA, three assisted living facilities, a hospice agency, a public library, nine primary care providers, and three skilled nursing facilities.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Massachusetts Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms “Better” and “Worse” to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
